³ A SIP telephone connection from AirIT can only be booked in conjunction with an AirIT internet connection.

⁴ The installation service can only be booked if the router is also purchased from AirIT. It includes the installation of the components provided by AirIT, including journey. A functioning house wiring is required.

⁵ An allocation of desired or consecutive phone numbers is not possible.
